DIRECTOR, KIDWAI MEMORIAL INSTITUTE OF ONCLOGY, an Autonomous body under the Govt. of Karnataka and a pioneering Institute in providing comprehensive Cancer care mainly for economically challenged Cancer Patients and it is also a Regional Centre for Cancer Research & Treatment having membership in INTERNATIONAL UNION AGAINST CANCER, located at Dr.M.H.Marigowda Road, Bengaluru – 560 029, represented by its Director **Dr.C.Ramachandra** herein after called the **DONEE**. (Which expression shall include all its successors and permitted assignees) of the other part.

WHERE AS:

DONEE owns Shanthidhama building, an in-patient specialty block with several individual Rooms for accommodating patients admitted for treatment. These rooms need renovation, repair and up gradation. Due to its budget constraints the **DONEE** has requested the **DONOR** to take up the renovation of rooms at Shanthidhama and on learning the **DONEE's** genuine requirement, the **DONOR** being interested in extending its help for charitable purpose has agreed and offered to extend its help in renovating One Room out of 36 Rooms in Shanthidhama i.e., Room No -07 (Seven).

Accordingly, the **DONAR** have taken up the proposal of Renovation of One Room of **KIDWAI MEMORIAL INSTITUTE OF ONCLOGY** in the Shanthidhama Block.

NOW THIS MEMORANDUM OF UNDERSTANDING is hereby entered by and between the parties here to as under

DONAR AGREE TO UNDERTAKE THE FOLLOWING.

1. Replacement of Flooring, Wall Cladding with Tiles and Painting to Room and Bathroom.
2. Providing Aluminum Windows with Three tracks Shutters (One shutter with Mosquito mesh and other Two with plain glass).
3. Providing Doors.
4. Providing Water supply & Sanitary fittings etc., complete and Geyser at Bath Room.
5. Donor agreed to take up the above items of work towards Renovation and repair of One Room at a cost of Rs.2,50,000/- (Rupees Two Lakh Fifty Thousand Only) and also meet incidental statutory taxes (GST).

DONEE AGREES.

To fix a common granite tablet stone engraved with the name of the list of other donors and in the list this particular Donor's Name being **Smt. M.S. Indira** after the satisfactory completion of the work duly certified by Asst. Executive Engineer, KMIO. Donor shall hand over the room to **DONEE** for further usage to **KMIO**.

To secure all the required clearances / sanction of the appropriate authorities in the matter concerning renovation of the Room No -07 of Shanthidhama and securing all that required services such as electricity, water supply, and the like.

The **DONEE** agrees to make available the following facilities for carrying out the renovation work by the contractor appointed by the **DONOR** by name *Jogadeesh Kumar. G. S*

Space at the site for godown to store the requisite materials.

Water and Power at a point near the renovation area, free of cost.

Access to all the sides of the Room No -07 of Shanthidhama for transporting men and materials and for carrying out the renovation work until completion of the work.
